Exhibiting at the SGA Farmers Markets is not permitted until your application is approved by the SGA Board of Directors. You will be notified by phone or mail of acceptance or denial. If accepted you shall:

- A. Pay a \$5 stall/table fee per day. No sales of products, raffle tickets or other fund raising items is allowed without the prior approval by the SGA Board of Directors. If you are approved to sell, you will be required to pay the daily stall fee of \$5 plus 4% if your total sales for the day. Whether or not any items are to be sold you are exempt from paying the \$35 annual membership fee and you will not be a voting member of the SGA.
- B. Make no solicitations outside of your assigned space. Do not approach customers while in communal walkways or other vendor booths.
- C. Provide your own canopy/tent, tables, signage or displays to identify your organization.
- D. Your canopy must be secured/weighted on all four sides with weights heavy enough to withstand winds.
- E. Prior to attending any market you must contact the Market Manager at our business phone line 226-7100 . Please state your name and the organization you are representing and provide a call back number. Let them know when your organization would be available to start and which market you would like to attend. This does not guarantee

you a space. If there is no space available, the Market Manager will contact you by phone. Please review the SGA Rules and Regulations regarding the notifications for attendance of and for missing markets.

F. You must arrive for the market prior to 7:00 am and be set up in your assigned space by 7:30. No late arrivals or early departures are allowed.

Having read the above application we request permission to exhibit at the Shasta Growers Association Farmers Markets. We have read and understand the Shasta Growers Association Rules and Regulations and agree to abide by them and cooperate fully with the SGA Board of Directors and the Market Managers. We fully understand that the failure to do so will result in dismissal from the markets. Limitation and/or denial to exhibit is at the discretion of the SGA Board and may occur at any time.
